Quick Reminder about Chapter Elections – From Committee on Law and Jurisprudence – Donna Harrist, Chairman

During Grand Chapter this past March when the Resolution concerning the Election of Chapter Officers passed, the Committee on Law and Jurisprudence reminded everyone that their Chapter By-laws needed to be updated in order to hold the Chapter Elections in November. We are working on several by-laws updates now and want to remind you it takes about two months to get the process completed. After the chapter has approved the amendments, they do not go into effect until the receipt of approval by the Committee on Law and Jurisprudence and the Worthy Grand Matron, attested by the signature and the seal of the Grand Secretary.
